We require that each adult living in the apartment be listed on the Lease Agreement. **Therefore, each adult needs to complete an application and provide all required documents.**

The application fee should be paid with a **money order**, made payable to Tower Management Service, LP, and returned to our Rental Office along with the completed application, identification and income documentation. **APPLICATIONS WILL NOT BE ACCEPTED FOR PROCESSING UNLESS ALL DOCUMENTATION IS COMPLETE.**

After your application has been accepted, processed and approved, you will need to provide a deposit equal to one months rent in the form of a cashier's check or money order, made payable to Tower Management Service, LP. The security deposit of 1 months rent, can be paid with a cashier's check or money order, and brought in at the time of your lease signing.

Please note that Tower Management Service, LP, complies with all State and Federal statutes including Title VIII of the Civil Rights Act of 1968 (Fair Housing Act) as amended, which prohibits discrimination in the sale, rental, and financing of dwellings, and in other housing-related transactions, based on race, color, national origin, religion, sex, familial status, (including children under the age of 18 living with parents or legal guardians, pregnant women, and people securing custody of children under the age of 18), handicap (disability) and any other protected characteristic.
